Dear President Rousseff,

The undersigned organizations urge you to take immediate steps to investigate recent allegations concerning illegal surveillance and infiltration of Brazilian human rights organizations and to prosecute any and all responsible parties.

In March of this year, the former director of intelligence for the Brazilian mining company Vale lodged a complaint with public authorities regarding illegal spying activities allegedly carried out by the company in collaboration with the Brazilian intelligence agency, Agência Brasileira de Inteligência (ABIN). The allegations concern phone tapping and illegal access to email and computer files. They also concern the infiltration of human rights organizations Justice on the Rails (Justiça nos Trilhos) and the Landless Workers' Movement (Movimento dos Trabalhadores Rurais Sem Terra – MST). According to the former intelligence officer, these infiltrations began in 2008 and are on-going.

The company has since acknowledged that it hired public intelligence personnel, and that it monitors both Justice on the Rails and the Landless Workers' Movement.

We call on the Brazilian government to undertake a thorough, timely and transparent investigation into these serious allegations, including an examination of the role played by public employees and agencies in any wrongdoing.

We further call on the Brazilian government to guarantee the human rights of personnel at Justice on the Rails and the Landless Workers' Movement, as required under international law.
